



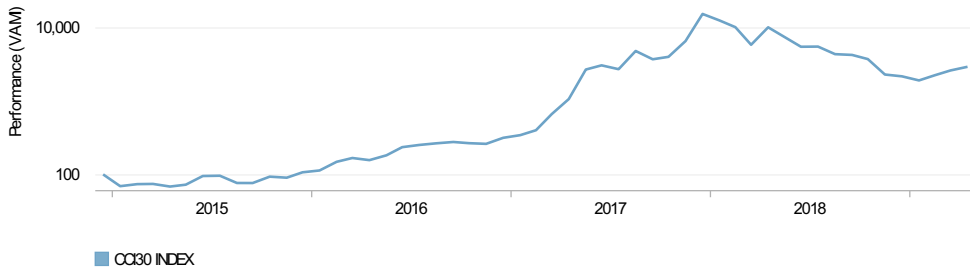

## DESCRIPTION

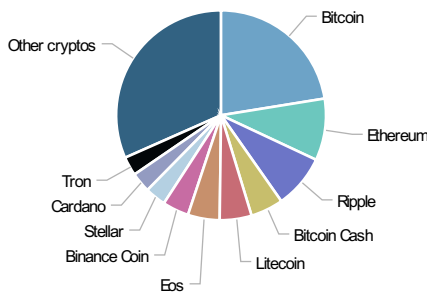
